She will be missed!



Mary Remembers:

I first visited the Village of Progress for a tour in 1979. I learned that the Village's Special Educator was going to be moving, which created an opening on the staff. After the tour I applied for the position and felt very fortunate to have been selected.

Working with adults with disabilities has been so rewarding. Over the years it has been such a thrill to see how the men and women we serve can, with the right accommodations, accomplish things that they didn't think they could do.

One of the highlights of my forty years here was when two of our individuals had the honor of participating in the 1987 International Summer Olympic Games held in South Bend, Indiana. (Alice Babler in swimming and Karen Young in bowling.) A group of us (other Special Olympians, parents and staff) took a bus to South Bend to cheer them on. It was an incredible experience. I'll never forget.

Another highlight occurred after our weekly swimming trip in Dixon (we now have the luxury of swimming at the Nash Center in Oregon). After leaving the YMCA we would stop for lunch at McDonalds. The managers and staff there were so accommodating. They always had tables reserved for us, mingled with our folks, and got to know them by name. They would even give everyone complimentary ice cream sundaes. Such hospitality. It was great to see the joy on the faces of the manager and our swimmers. Friendships formed in both directions!

As my season at the Village comes to a close, I feel blessed to have had so many years working with our men and women and with such a dedicated, caring staff.

Kelly comes to the Village with high
recommendations and years of on the job
experience with adults with disabilities.
Kelly has been able to spend 5 weeks directly with Mary learning all her responsibilities. We welcome Kelly to the VOP family.

3rd Annual TOSOC (Tour of Scenic Ogle County)

TŌSOC – the <u>T</u>our of <u>S</u>cenic <u>Og</u>le <u>C</u>ounty kicked off Saturday, September 22nd. The first riders started pulling into the Village's parking lot to unload their bikes and pump up their tires as early as 6:15 a.m. – over an hour before registration opened at 7:30 a.m. By the time registration closed, over 300 cyclists had signed up and were out on the road. TŌSOC was developed with the help of Oregon resident and cycling enthusiast Scott Stephens. Stephens was instrumental in developing a number of biking routes around Ogle County, including the TOSOC routes.

TŌSOC had three cycling routes to choose from. The first was a **10 mile family ride** through Oregon. Developed with the help of the Oregon Park District, this ride toured a number of the city's parks. **A 32 mile route** took cyclists through Grand Detour (stopping at the John Deere Historical Museum) and the Nachusa Grasslands for Bison viewing; **a 62 mile loop** added in some of the scenic areas north of Mount Morris and west of Daysville.

By the end of the day, TŌSOC netted approximately **\$11,000** for the Village's Attendance Grant Program. Attendance Grants were developed by the Village in 2014 because so many people with disabilities, people who are entitled to services, cannot receive them because Illinois lacks the funding. TŌSOC proceeds will provide 169 days of attendance. Attendance grants are awarded to men and women in Ogle County, enabling them to attend the Village on a part time basis. 
Village of Progress — By The Numbers
